I have enclosed two separate checks each in the amount of \$35.00 for your fee to process the name changes.

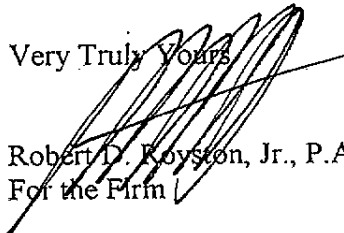
