

ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE ONE
NAME

The name of this corporation is Aladin Enterprises Inc.

ARTICLE TWO
DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE
PURPOSES

The purpose for which the corporation is organized is:
To engage in any activities or business permitted under the laws of the United States and Florida.


