The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be: S & K CONSTRUCTION, inc.

The term of existence of the corporation is perpetual.
