THE UNDERSIGNED subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of the corporation is: **FAME BROKERAGE, INC.** The official street and mailing address for the corporation is: **5301 North Dixie Highway, Suite 216, Fort Lauderdale, Florida 33334.**

**ARTICLE II - PURPOSE OF CORPORATION**

This corporation is organized for the purposes of conducting any and all lawful activity or business for which corporations may be incorporated and permitted under the laws of the United States and of the State of Florida.

**ARTICLE III - CAPITAL STOCK**

This corporation is authorized to issue five hundred (500) shares of One Dollar (\$1.00) par value common stock.

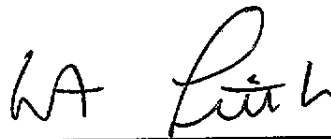
The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.
