**ARTICLES OF INCORPORATION**  
**OF**

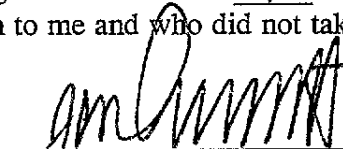

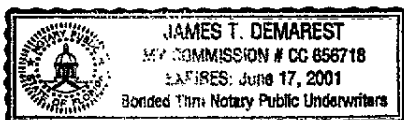

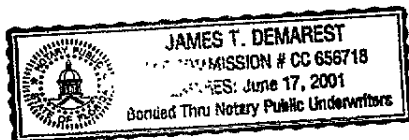
