

ARTICLE ONE

The name of the corporation is TriO Computer Sales and Service, Inc. The principal address of the corporation is: 1859 North Pine Island Road, Suite 273, Plantation, Florida 33322.

ARTICLE EIGHT


The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.
