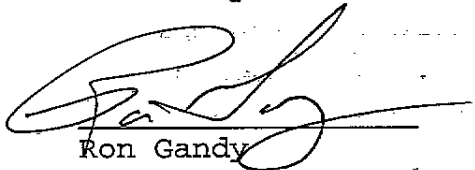

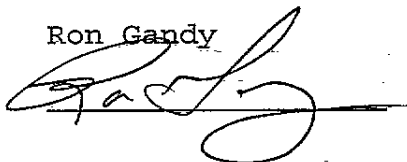

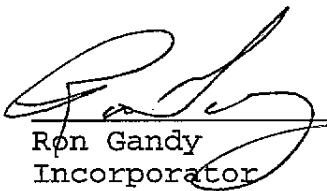


ARTICLE X POWER TO FORM PARTNERSHIP

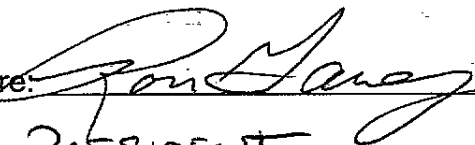

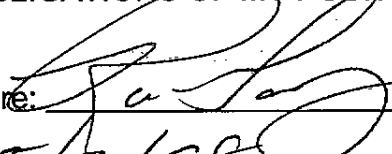
