# ARTICLES OF INCORPORATION OF

CREEL'S STUCCO & MASONRY, INC. (a corporation for profit)

The undersigned, for the purpose of forming a corporation for profit under the provisions of the Florida Business Corporation Act, do hereby adopt the following Articles of Incorporation.

### ARTICLE I

The name of this corporation is CREEL'S STUCCO & MASONRY, INC.

## ARTICLE II DURATION

This corporation shall have perpetual duration. The corporate existence shall begin with the date and time of the filing of these Articles of Incorporation by the Florida Department of State.

# ARTICLE III PURPOSES AND POWERS
