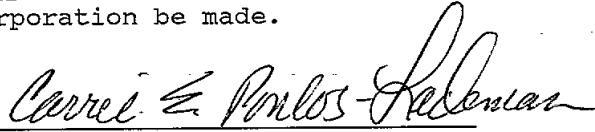

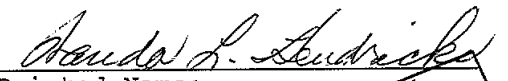
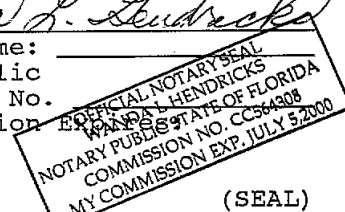
XI. AMENDMENTS

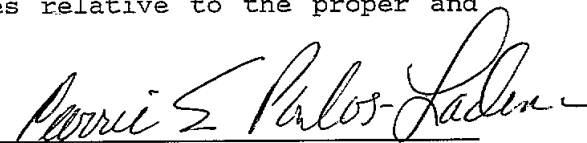
