ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Act, adopts the following Articles of Incorporation for such a corporation:

Article I

Name of Corporation: Coral Roc, Inc.

Article IV

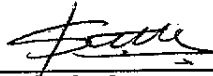
