ARTICLE ONE. NAME

The name of the corporation is PEREZ TEAM, INC.

ARTICLE TWO. PURPOSE

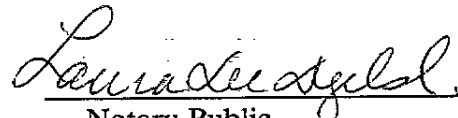

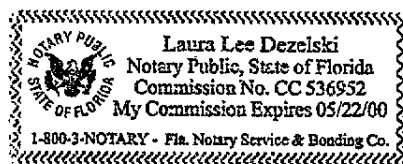

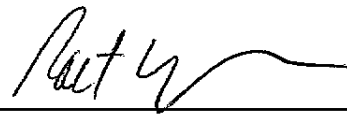
