(A SMALL BUSINESS CORPORATION)

We, the undersigned, with other persons being desirous of forming a corporation, under the Laws of the State of Florida, by and under the provisions of the Florida Statutes, providing for the formulation, liability, rights, privileges, and immunities of a Corporation for profit, state the following:

ARTICLE I

The name of the corporation shall be:

HOOPER, INC.

a for profit Corporation organized under *Chapter 607 Florida Statutes*.

ARTICLE II

The address of the principal office of this corporation shall be:

ARTICLE III

The general purpose for which **HOOPER, INC.**, is organized is:

To acquire by purchase, lease, otherwise, lands and interest in lands, and to own, hold, improve, develop and manage any real estate so acquired, and to erect, or cause to be erected on

any lands owned, held or accepted by the corporation, buildings or other structures, public or private, with their appurtenances, and to manage, operate, lease, rent, rebuild, enlarge, alter or improve any buildings or other structures, now or hereafter erected on any lands so owned, held or occupied, and to encumber or dispose of any lands, or interest in lands, and any buildings or other structures, at any time owned or held, by the corporation. To buy, sell, mortgage, exchange, lease, hold for investment or unimproved, and any right or interest therein.

To acquire, by purchase, lease, manufacture, or otherwise any personal property deemed necessary or useful in the equipment, furnishing, improvement, development or management of any property, real or personal, at any time owned, held or occupied by the corporation, and to invest, trade and deal in any personal property deemed beneficial to the corporation, and to lease, rent, encumber or dispose of any personal property at any time owned or held by the corporation.

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness and execute such mortgages, transfer of corporate property or other instruments to secure the payment of corporate indebtedness as required.

To purchase the corporate assets of any other corporation and engage in the same or other character of business.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of capital stock of, or any bonds, and securities, or other evidences of indebtedness created by any other corporation, of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of

To enter into, make, perform, and carry out contracts and agreements of every kind, for any lawful purpose, without limit as to amount, with any person, firm association or corporation, and to transact any further and other business necessary or necessarily connected with the purpose of this corporation, or calculated to facilitate the same.

To carry on any or all of its operations and businesses, and to promote its objects within the State of Florida, or elsewhere, without restriction as to place or amount, and to have use, exercise and enjoyment of all of the general powers of like corporations.

To do any and/or all of the things herein set forth to the same extent as natural persons might or could do, and in any part of the world as principals, agents, contractors, or otherwise, alone, or in company with others, and to do and perform all such other things and acts as may be necessary, profitable, or expedient in carrying on any of the business or acts named above.

To transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the Board of Directors of the Corporation, be advantageously carried on in connection with or auxiliary to the foregoing business; and to do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

The intention is that none of the objects and powers as herein above set forth, except where otherwise specified in this Article, shall be in any way limited or restricted by reference to or interference from the terms of any other Articles but that the objects and powers specified in each

The total number of shares of stock which **HOOPER, INC.** is authorized to issue is ONE THOUSAND (1,000) shares of common stock having a par value of \$1.00 per share.
