

ARTICLES OF INCORPORATION

NATIONWIDE CLEARINGHOUSE CORP.

ARTICLE 1: NAME

The name of this corporation is NATIONWIDE CLEARINGHOUSE CORP.

ARTICLE 2: DURATION

This Corporation shall exist perpetually, commencing as of May 12, 1998.

ARTICLE 3: PURPOSE

This Corporation is organized for the purposes of engaging in all lawful purposes allowed under the Florida Corporation Act.

ARTICLE 4: CAPITAL STOCK

This Corporation is authorized to issue 100 shares of \$1.00 par value common stock.

ARTICLE 5: INITIAL REGISTERED OFFICE AND AGENT
AND PRINCIPAL OFFICE

ARTICLE 6: INITIAL BOARD OF DIRECTORS

This Corporation initially shall have one director. The number of directors may be either increased or diminished from time to time by the Bylaws but shall never be less than one nor greater than five. The names and addresses of the initial director of this Corporation is as follows:

The Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE 11: BYLAWS
