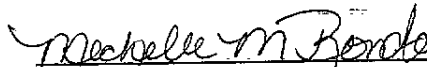
ARTICLE IX. AMENDMENT

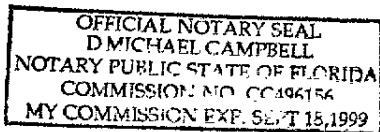
