Dear DoC personnel,

I contacted your office yesterday and talked to one of your representatives about the **second notice** I received about my UBR filing. I explained that I did **not** have record of receiving a **first notice** and was confused.

I was informed that I should write a letter explaining that I do not believe I received the **first notice** and send the \$150 filing fee plus \$8.75 for a **certificate of status**. I was told I should not be charged the late fee of \$400, though I still might be charged anyway.

It is my hope that this letter of explanation and intent are enough to suffice. Ours is a small, crafting business that makes only about \$4000 in gross sales a year (garage based crafting). The fine would constitute about 1/10th of our total sales and is more than we presently have in the business bank account.

Thank you for your assistance. If this payment is not acceptable and I will be required to pay the additional \$400 late fee, please contact me as soon as possible so I can obtain the funds.
