The Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

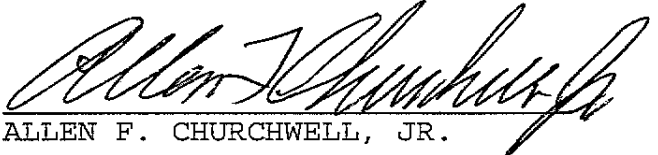
ARTICLE X - AMENDMENT

This Corporation is authorized to issue 1,000 shares of One Hundred Dollar (\$100.00) par value.

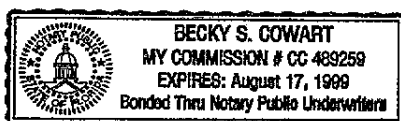

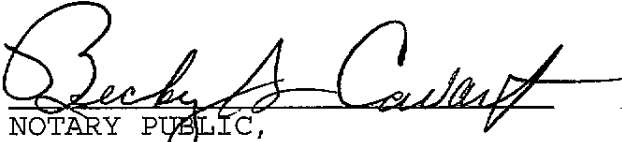

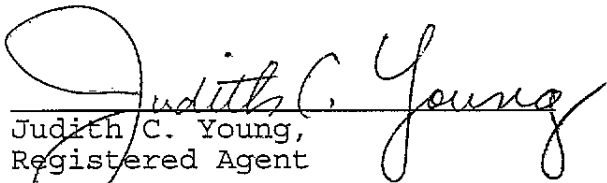
