

ARTICLE XI - OFFICES



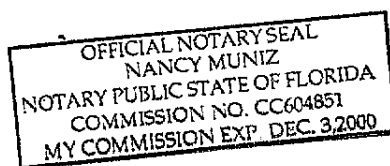
