## ARTICLES OF INCORPORATION

### ARTICLE I - NAME

The name of this corporation is Allan M. Migdall, P.A.

### ARTICLE II - PRINCIPAL OFFICE

### ARTICLE III - PURPOSE

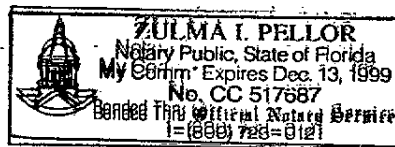
