**ARTICLES OF INCORPORATION

ARTICLE ONE

The name of the corporation is Plantation Group, Inc.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have the authority to issue is two hundred of no par value.

ARTICLE FIVE

The corporation will not commence business until it has received for the issuance of shares consideration of the value of one thousand dollars consisting of money, labor done or property actually received.

ARTICLE SIX

The street address of its initial registered office and the name of its initial registered agent is Dean Yankopoulos, c/o Plantation Group, Inc., 140 N.W. 108th Terrace, #301, Pembroke Pines, FL 33026. This is also the principal mailing address of the corporation.

ARTICLE SEVEN

The number of directors constituting the initial board of directors is one, and the name and address of the person who is to serve as director until the first annual meeting of the shareholders or until their successors are elected and qualified is Dean Yankopoulos, c/o Plantation Group, Inc., 140 N.W. 108th Terrace, #301, Pembroke Pines, FL 33026.

ARTICLE EIGHT

The Board of Directors is empowered to make, alter or repeal the Bylaws of the Corporation without restriction of their powers conferred by statute.

ARTICLE NINE

The name and address of the incorporator is: Dean Yankopoulos, c/o Plantation Group, Inc., 140 N.W. 108th Terrace, #301, Pembroke Pines, FL 33026.

I hereby accept the designation as registered agent.
