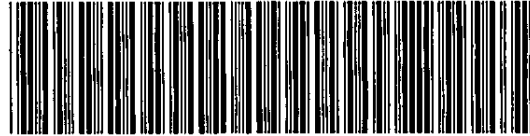



3. Amendment Adopted: Article I of the Articles of Incorporation is hereby amended in its entirety to read as follows:


"ARTICLE I
