The undersigned, acting as incorporator of a Florida General Corporation Act, Chapter 607, Florida Statutes, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME

The name of the corporation is SEBASTIEN INTERNATIONAL, INC.

ARTICLE II. DURATION

The corporation shall be perpetual existence unless sooner dissolved according to law.

ARTICLE III

The corporation is organized for the purpose of transacting any and all lawful business for which corporations may be in the state of florida.

ARTICLE IV

The corporation is authorized to issue:
1,000 shares of common stock at par value of \$1.00 per share


