When I originally registered the company I was informed that the benefits package offered by the registration attorneys included the first years annual report.

I was therefore confident in the knowledge that they would take care of submitting the report and as my registered agents would be receiving copies of anything sent to me.

On receiving your notice of administrative dissolution I immediately contacted the attorneys, only to be told that the benefits touted by them were infact terminated after a period of three months and that I should have paid a further \$89.95 had I wanted them to continue.

I find this an extremely misleading way to conduct business, as the annual report by default would not be due in three months and so should not be promoted as a benefit of registering with this particular firm.

I hope you will look with kindness on my situation as this is my first year of conducting business, which I operate from my home. I am trying very hard to make a success of things but unfortunately made a substantial loss for the year.

I will find it very difficult to pay the reinstatement fee and again on the advice of Christen am sending \$150 (check enclosed) in the hope that the company will be reinstated.
