The undersigned, acting as incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

**ARTICLE 1. NAME**

The name of the corporation is **TRADEWINDS INSPECTION AND CONSULTING, INCORPORATED**

**ARTICLE 11. DURATION**

The corporation shall have perpetual existence.

**ARTICLE III. PURPOSE**

The corporation shall have the power, privilege and right to engage in any activity of business permitted under the Laws of the United States and the State of Florida.




