BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida Law.

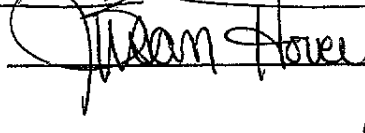
1. *Name.* The name of the corporation is PRECISION SALES & SERVICE, INC.
