In preparing the 1999 corporate tax return for my client, Proverb Communications Inc, I noticed there had not been a check written for \$150 to the State of Florida. I questioned him about it, and he said he did not know anything about a check for \$150. I further questioned him about receiving a green and white envelope, a red and white envelope or a black and white 9 x 12 envelope from the State of Florida. David Proverb, the President of Proverb Communications Inc, stated he had not seen any of these envelopes, and his wife handled all the mail. They have a home based business.

He went home to ask her about the envelopes, and called me and said yes, he had a green and white and a red and white envelope, but no black and white envelope. I advised him he had a problem because his corporation had been administratively dissolved, and it would probably cost over a \$1000 to have it reinstated. His business has not been doing very well, and he does not have the \$1000. I suggested he contact the State and explain the situation, and ask if he has any other options. His phone call to the State Division of Corporations resulted in the advice of sending in a letter of explanation, and depending if the explanation met certain criteria, a possible abatement of late filing penalties could be obtained.

It has been my experience the truth is always the best explanation. Mr. Proverb was not aware, as many new corporate entities, of the annual fee necessary to keep his corporation current. Neither was his wife, and therefore filed the forms away, not realizing any action was necessary. The situation did not come to light until I began to work on their 1999 corporate tax return (which is now, as I filed an extension on 3/15/2000), and did not find the \$150 expense



check. We therefore request an abatement consideration as this was not an intentional and negligent disregard of the rules, but a sincere mistake.
