ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE I

The name of the corporation is **PYRAMID GENERAL SERVICES, INC.**

The period of duration is perpetual.

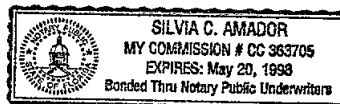
