The undersigned subscribers of these Articles of Incorporation each a natural person competent to contract, hereby associates themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

The name of this corporation is ROBERT D. HAIR, INC. with its primary place of business is North Miami, Dade County, Florida.

ARTICLE II

The general nature of the business to be transacted by this corporation is:

The transporation of personal by limouzine and small multiple passenger motor vehicles. The primary and sole operator under this corporation is Robert Daniel Hair, who will act as an independent contractor who contracts with transporation providers for the sole service of transporting persons to and from designated destinations as per his contract with the primary transporation provider. Although the sole operator under the corporation Robert Daniel Hair may at his choosing engage in the transporation of persons through the use of his own motor vehicles if he so desires same vehicles to be affiliated with this corporation.

This corporation may, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign transfer or otherwise dispose of, and to invest in, trade in, deal in, and with goods, wares, merchandise, real and personal in nature, and service, of every class, and description that he may be licensed to perform by the appropriate governmental entity regulating the business of transporation of persons for public transporation be it private or public in nature, but this corporation may not engage in banking, safe deposit, trust, insurance, surety, reailroad, canal, telephone or cemetery company, a building and loan

association, mutual fire insurance association, co-operative association, internal benefit society, state fair, or exposition.

To conduct business, in, have one, or more offices, in and buy, hold, mortgage, sell convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademark, and licenses in the State of Florida, and in all other states, countries, where permitted by law.

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes, and other evidence of indebtedness, and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required.

To purchase the corporate assets of any other corporation and engage in the same other character of business.

### ARTICLE III

The maximum number of shares of stock that this corporation is initially authorized to have outstanding at any one time is one-hundred (100) shares of common stock without nominal or par value. The consideration to be paid for each share of stock is to be fixed by the Board of Directors.

### ARTICLE IV

The street address of the principal offices of this corporation in the State of Florida, is in North Miami, Dade County, is 13511 North East 21st Court, North Miami, Florida 33181. The Board of Directors may from time to time move the principal offices to any other address in the State of Florida.

### ARTICLE V

This corporation is to exist in perpetuity.

ARTICLE VI

This corporation shall have one director initially. The number of directors, may be increased or diminished from time to time .

ARTICLE VII

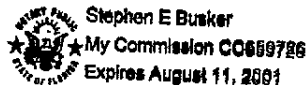
