The undersigned, for the purposes of forming a professional corporation under and pursuant to the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I
NAME

The name of the professional corporation is Michael J. Konzela, D.D.S., P.A.

ARTICLE II
PURPOSES

The professional corporation is organized pursuant to Chapter 621, Florida Statutes, for the sole and specific purpose of rendering any or all professional services rendered by doctors of dentistry and to engage in any or all lawful business and activities in which such a professional corporation may engage.

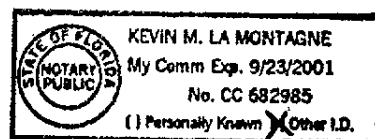
