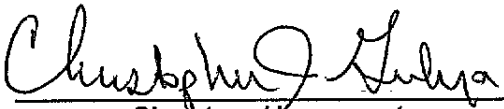

This corporation is to exist perpetually. The effective date of this corporation is May 14, 1998.

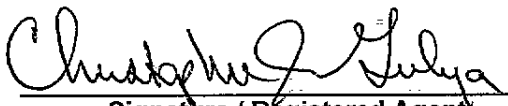
