ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming corporation under the Florida Business Corporation Act, Chapter 60% of the Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I: NAME OF THE CORPORATION
