**ARTICLES OF DISSOLUTION
OF
ORGANIZATIONAL CAPITAL PARTNERS (USA) INC.,
A FLORIDA CORPORATION**

Pursuant to the provisions of Section 607.1403 of the Florida Statutes, ORGANIZATIONAL CAPITAL PARTNERS (USA) INC., a Florida corporation (the "Corporation"), adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is Organizational Capital Partners (USA) Inc.
2. The Corporation was incorporated on February 28, 2014, and the document number of the Corporation is P98000044782. *Previously MVC Management Corp.*
3. The dissolution was authorized on February 14, 2020, by the unanimous written consent of the shareholders of the Corporation as permitted pursuant to Section 607.1402(6) of the Florida Statutes.
4. The number of votes cast by the shareholders in favor of dissolution was sufficient for approval, and voting by voting groups was not required.
5. The effective date of the dissolution shall be June 30, 2020.
