

**ARTICLES OF INCORPORATION  
OF  
N & L Boats, Inc.**

**ARTICLE I - NAME**

The name of this Corporation shall be:  
N & L Boats, Inc.

**EFFECTIVE DATE**

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing  
on 05/07/98

**ARTICLE III - PURPOSE**

This Corporation is organized for the purpose of transacting  
any and all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This Corporation is authorized to issue Two Hundred (200)  
shares of \$1.00 Par Value Stock.

**ARTICLE V - VOTING RIGHTS**

Except as otherwise provided by law, the entire voting power  
for the election of Directors and for all other purposes shall be  
vested exclusively in the holders of the outstanding common shares.
