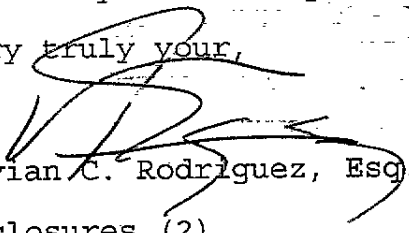

**ARTICLES OF INCORPORATION OF  
PADRON REPAIRS & CONSTRUCTIONS CO.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

**ARTICLE ONE**

**NAME AND ADDRESS**

The name of the corporation is PADRON REPAIRS & CONSTRUCTIONS CO., and its initial address is 144 NE 20<sup>th</sup> Terrace, Miami, FL 33137.

**ARTICLE TWO**

**CORPORATE DURATION**

The duration of the corporation is perpetual.

**ARTICLE THREE**

**PURPOSE OR PURPOSES**

The general purposes for which the corporation is organized are:

1. To engage in the business of general repair and constructions services.
2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

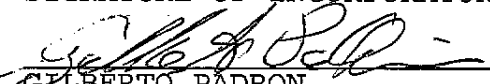

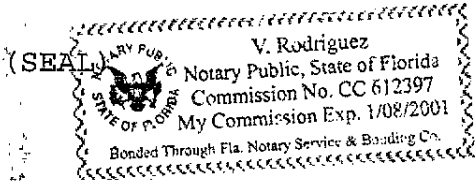
