ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I. NAME

The name of this corporation shall be W.B. TECHNICAL SERVICES, INC.

ARTICLE II. CAPITAL STOCK

The maximum number of shares of stock that this corporation shall be authorized to issue and to have outstanding at any one time shall be limited to one thousand shares of common stock.

ARTICLE V. TERM OF EXISTENCE

The existence of this corporation shall continue perpetually unless dissolved by law. The effective date of this corporation shall be the date of its incorporation.

ARTICLE VI. ADDRESS

The street and mailing address of the initial principal office of this corporation in the State of Florida is 12 Dawson Drive,

Palm Coast, Florida 32137. The corporation designates Paul Washko, located at 12 Dawson Drive, Palm Coast, Florida 32137, as its agent to accept service of process within the State, and said office shall be designated as the corporation's initial registered office.

ARTICLE VII. DIRECTORS

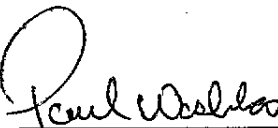
This corporation shall not have a Board of Directors and the initial shareholders of this corporation shall exercise all powers, duties and responsibilities of the Board of Directors under Florida law.
