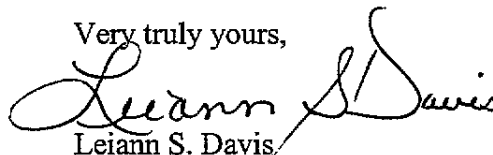

BYLAWS

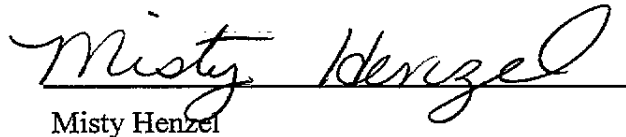
