

ARTICLES OF INCORPORATION OF HANANIA IMPORTS, INC.

ARTICLE VIII-AMENDMENTS


This Corporation may amend, alter or repeal any provision of these Articles of Incorporation in the manner now or hereinafter provided by Florida law.
