The undersigned, acting as incorporator of **Kobayashi International, Inc.**, under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation (the "Corporation") is Kobayashi International, Inc.

ARTICLE II

ADDRESS

The street address of this Corporation shall be 389 Grentham F, Deerfield Beach, FL 33442 and the mailing address of this Corporation shall be 1560 NW 101st Way, Plantation, FL 33322.

ARTICLE III

DURATION

The duration of the Corporation shall be perpetual.
