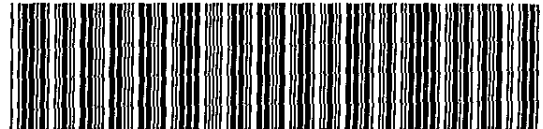

ARTICLE XII = OFFICERS




