## OF

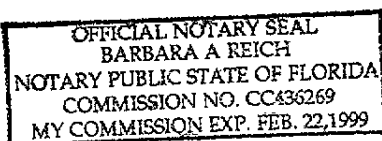



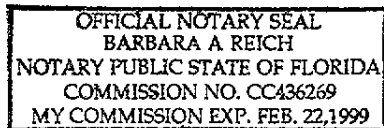
