The undersigned, for the purpose of forming a corporation (the "Corporation") under the provisions of Chapter 607 of the Florida Statutes, hereby agrees to the following:

ARTICLE I Name and Address

The name of the Corporation shall be MCLV DEVELOPMENT, INC. The street and mailing addresses of the initial principal office of the Corporation shall be 920 Tennessee Lane, Sarasota, Florida 34234.

ARTICLE II Purpose and Powers

This right may also be waived by affirmative written waiver submitted by the shareholder to the Corporation within thirty (30) days of receipt of notice from the Corporation.

ARTICLE VI Board of Directors

Section 1. The business and affairs of the Corporation shall be managed by a Board of Directors, the members of which shall be hereinafter referred to as Directors.
