We, the undersigned, hereby associate together for the purpose becoming a corporation under the laws of the State of Florida, and for the formation, liabilities, rights, privileges, and immunities of a corporation for profit.

The name of the Corporation shall be, Collier & Collier Enterprises, Inc. its principal business shall be carried on at 418 S. Clara Ave., DeLand, Florida 32720 and at such other places or points in the State of Florida, and the United States and foreign countries as may from time to time be authorized by the board of Directors.

ARTICLE II

The general nature of the business or businesses to be transacted by this Corporation is as follows:

SECTION 1

To conduct a general business is any activity allowed by law.

SECTION 2

SECTION 4
