ARTICLES OF INCORPORATION OF TAYLOR'S TREE SERVICE, INC.

The undersigned incorporator(s), for the purpose of forming a corporation under the Florida AM IO: 10 Business Corporation Act, hereby adopt(s) the following Articles of Incorporation LAHASSEE FLORIDS:

ARTICLE I - NAME
