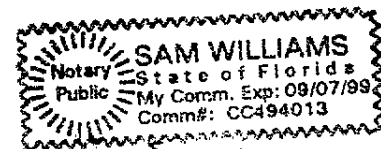

ARTICLES OF INCORPORATION: AL'S COOL DUCT, COMPANY

ARTICLE I The name of the corporation is: AL'S COOL DUCT, CO.

ARTICLE VI The number of directors shall be not less than one or more than seven. A vacancy on the Board of Directors may be filled by the Board of Directors.

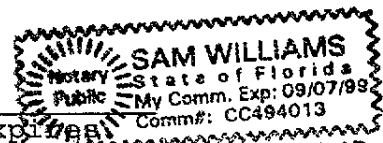
