**ARTICLE I - NAME**

The name of the corporation is The Big Idea Sales Promotion Agency, Inc.  
(hereinafter called the "Corporation").

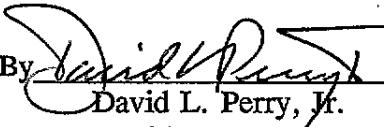

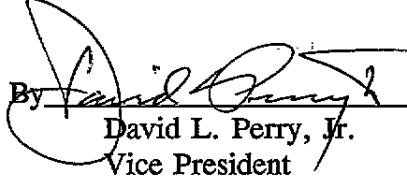
