This Corporation is organized for the purpose of transacting any or all lawful business.


**ARTICLE IV

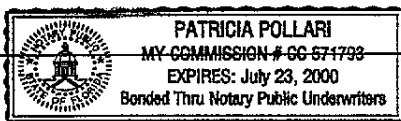
