ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SPECTRUM PERSONNEL, INC.

THE UNDERSIGNED, John W. Beebe, President of SPECTRUM PERSONNEL, INC., a Florida corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is SPECTRUM PERSONNEL, INC.

ARTICLE SECOND: The amendment to the Articles of Incorporation of the Corporation offsected by these Articles of Amendment is that ARTICLE 1 of the current Articles of Incorporation is amended to provide as follows:

"ARTICLE I - NAME OF CORPORATION. The name of this Corporation shall be CHARGE CARD SERVICES, INC."
