2. Article One of the Articles of Incorporation is amended, in its entirety, to read as follows:

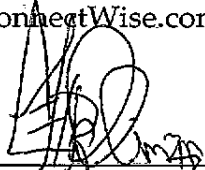
The name of this corporation is ConnectWise.com, Inc.

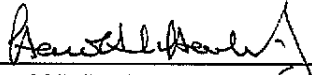
