THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to Chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation.

WITNESSETH:

**ARTICLE I
NAME**

The name of the corporation is:

WORLD SHOOTING HERITAGE FOUNDATION, INC.

**ARTICLE II
DURATION**

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation with the Department of State of the State of Florida.

**ARTICLE III
PURPOSES**

This corporation is organized for the purpose of transacting any and all lawful business.

**ARTICLE IV
CAPITAL STOCK**

This corporation is authorized to issue 70,000 shares of Class A Common Stock with no par value and 30,000 shares of Class B Common Stock with no par value.

**ARTICLE V
VOTING RIGHTS**

The Class A Common Stock of the corporation shall have voting rights. Except as to the extent prohibited by Chapter 607, Florida Statutes, the Florida Business Corporation Act, the Class B Common Stock shall have no right to vote.

**ARTICLE VI
QUORUM FOR SHAREHOLDER'S MEETINGS**

Unless otherwise provided for in the corporation's bylaws, a majority of the shares entitled to vote, represented in person or by proxy, shall be required to constitute a quorum at a meeting of shareholders.

**ARTICLE VII

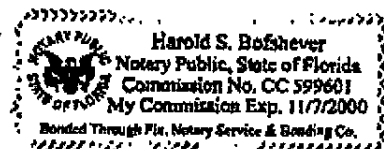
