Indemnification

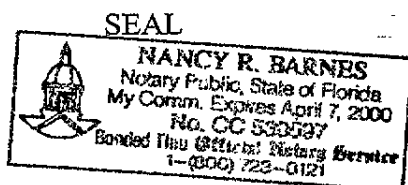


