
ARTICLE IX. CORPORATE POWERS

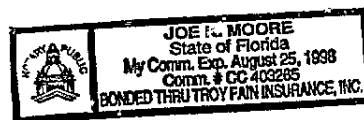
